PROCEDURE FOR APPOINTING A CONSULTANT UNDER THE PANEL UPON IDENTIFYING A PROJECT

STEP 1

STEP 2

• The Potential service providers will be further subjected to selection based on the level (Level 1 – Level 4) which the projects' estimated price falls under.

STEP 3

ERWAT will invite the selected bidders from the respective level and discipline to submit a quotation in the form of a modified, limited tender document including: Bill of Quantities (based on the promulgated scale of fees), functionality evaluation and declaration forms. In the case where no promulgated scale of fees is available, the ECSA scale of fees will take precedence.

STEP 4

- Upon submission, ERWAT will follow PPPFA & related regulations (including BBBEE) to select the successful bidder from those who respond to invitation.
