

NOTE TO BIDDERS:

1. Page 6 of 215 of the tender document, F.2.1 – CIDB Requirement states that the lead partner should have the advertised CIDB grading. This is contrary to what CIDB requires. Please be advised that CIDB takes precedence. All partners to a JV must be individually registered in their own right. Their combined grading may be determined using the CIDB Joint Venture Calculator. CIDB states "The lead partner must be registered in a contractor grading designation not lower than one level below the required grading designation in the class of construction works under consideration. The joint venture calculator sums the capacity of all the joint venture partners and calculated a grading designation for the joint venture."
2. The tender closing date has been extended to **10 June 2022 at 12H00**. All bids must be hand delivered and deposited in to the ERWAT Public Tender boxes in a sealed envelope, clearly marked with the tender number and description.
