NOTICE TO BIDDERS

VERY IMPORTANT NOTICE ON DISQUALIFICATIONS:

A bid not complying with the peremptory requirements stated hereunder will be regarded as not being an "Acceptable bid", and as such will be rejected.

"Acceptable bid" means any bid which, in all respects, complies with the conditions of bid and specifications as set out in the bid documents.

To ensure that your bid is not exposed to invalidation, documents are to be completed in accordance with the conditions and bid rules contained in the bid documents. The lowest or any bid will not necessarily be accepted, and ERWAT reserves the right not to consider any bid not or a bid not comprehensively completed as well as the right to accept a bid in whole or part. TERMS OF REFERENCE

FPQ202302/007: SUPPLY, DELIVERY, AND INSTALLATION OF NEW CARPET IN THE ERWAT AUDITORIUM

1. SCOPE OF WORK AND DELIVERY POINT

Bidders are hereby invited to submit an offer for the supply, delivery and installation of new carpets in the ERWAT Auditorium. Bidders must price for the removal of the existing carpet, removal from site, preparation of floor area, supply, delivery and installation of a new carpet including accessories at the ERWAT auditorium. The auditorium is deemed to be a high traffic area and thus a fire, stain resistant, resilient and good quality fabric (wool or nylon) to be offered.

Bidders will be required to bring samples of carpets, strips and skirtings together with the quotation for inspection. ERWAT wishes to keep the carpet standardised to the existing or better.

The auditorium has various levels and is odd shaped. The size of the floor area including the emergency exit areas, steps and levels is estimated at $\pm 160 \, \text{M}^2$. Bidders are required to inspect and advise on accurate m^2 before submitting their offer and bidder are welcome to make an appointment to verify measurement at their own time.

Bidders to provide all materials, labour, consumables and strips for the areas where required.

The auditorium currently has wooden skirtings and bidders to offer option to re-place the current wooden skirtings and offer option 2 to replace with aluminium skirtings. ERWAT reserves the right choose a final option. Bidders will be required to sign a waybill from ERWAT to remove the extracted carpet from ERWAT site and this will be arranged in collaboration with the Security section. Failure to have this waybill, will prevent the bidder from leaving with the extracted carpet, etc. through security at ERWAT.

The bidder is required to ensure full compliance with the occupational, Health and Safety Act as well as PPE criteria. Failure to comply will lead to bidders being refused access to site.

PLEASE NOTE THE SAFETY FILE WILL BE REQIURED BEFORE ANY WORK COULD START, THERFORE THE BIDDER MUST MAKE PROVISSION IN THEIR PRICES.
