The lowest or any bid will not necessarily be accepted, and ERWAT reserves the right not to consider any bid not or a bid not comprehensively completed as well as the right to accept a bid in whole or part. ### A BID WILL BE REJECTED:

- If bidders are not compliant with all applicable legislative requirements, as per CSD.
