NOTICE TO BIDDERS

VERY IMPORTANT NOTICE ON DISQUALIFICATIONS:

A bid not complying with the peremptory requirements stated hereunder will be regarded as not being an "Acceptable bid", and as such will be rejected.

"Acceptable bid" means any bid which, in all respects, complies with the conditions of bid and specifications as set out in the bid documents.

To ensure that your bid is not exposed to invalidation, documents are to be completed in accordance with the conditions and bid rules contained in the bid documents. The lowest or any bid will not necessarily be accepted, and ERWAT reserves the right not to consider any bid not or a bid not comprehensively completed as well as the right to accept a bid in whole or part. ERWAT reserves the right to appoint more than one bid for this contract.

A BID WILL BE REJECTED:

- If bidders are not compliant with all applicable legislative requirements, as per CSD. 1. SCOPE OF WORK

Tubes are used for digestion of samples before sample analysis for Total Kjeldahl Nitrogen/Total Phosphorus (TKN/TP).

The samples are available for measurements at our laboratory. Arrangements can be made for measurements at our Laboratory .8:30 -15:00.

2. MANDATORY REQUIREMENTS

- Municipal account statement not older than 3 months and not owing for 90+days or a valid lease agreement signed by lessee and lessor.
