NOTICE TO BIDDERS

VERY IMPORTANT NOTICE ON DISQUALIFICATIONS:

A bid not complying with the peremptory requirements stated hereunder will be regarded as not being an "Acceptable bid", and as such will be rejected.

"Acceptable bid" means any bid which, in all respects, complies with the conditions of bid and specifications as set out in the bid documents.

To ensure that your bid is not exposed to invalidation, documents are to be completed in accordance with the conditions and bid rules contained in the bid documents. The lowest or any bid will not necessarily be accepted, and ERWAT reserves the right not to consider any bid not or a bid not comprehensively completed as well as the right to accept a bid in whole or part. ERWAT reserves the right to appoint more than one bid for this contract.

A BID WILL BE REJECTED:

- If bidders are not compliant with all applicable legislative requirements, as per CSD. National Treasury in partnership with the Provincial Treasury have developed municipalities and municipal entities with a Central Supplier Database (CSD) for the registration of prospective suppliers in line with Section 14(1) (b) of the Municipal Supply Chain Management Regulations (MSCMR). 1. SCOPE OF WORK

Please provide a quotation for the supply and delivery of the following services/items:

- On-site service and validation of a RotorGene 6000 2-plex thermal cycler with HRM capability
- The service must include temperature and optical validation of the instrument.
- Quotations must include all labour and travel costs.

VERY IMPORTANT:

- All prices quoted must include 15% value added tax (VAT)
- Bidders or technicians to perform the service and validation <u>MUST</u> be trained and qualified to perform work a RotorGene 6000 2-plex thermal cycler with HRM capability.
- Proof of training or certification to perform service and validations of RotorGene 6000 2-plex thermal cyclers with HRM capability MUST be provided. Failure to do so will lead to disqualification of the bid.
- All equipment serviced and validated must be labelled to indicate the status of validation (date validated and next service and validation due).
- Expiry date/s or the next service and validation due date must be indicated on the certificates for each equipment and <u>MUST</u> be as per the schedules stipulated by ERWAT.
- Certificates must be submitted to ERWAT by latest two weeks after the services and validation have been completed.

Bids received electronically after the closing date and time will not be accepted for consideration and where applicable.

6. FRONTING

ERWAT supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background ERWAT condemns any form of fronting.

ERWAT, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents.
